### **New year, new incentives!**

VEC's offering an [expanded menu of financial incentives](#) this year to help members, including commercial and industrial members, move away from fossil fuels to electricity and advanced wood heating. Of particular interest to business members may be our Clean Air Program that can bring clean and convenient electricity to commercial facilities that currently rely on fossil fuels.

### **Holding rates steady, four years running**

VEC is keeping rates in check. This year marks the fourth consecutive year that VEC [has kept rates flat](#), and at least one business owner says he was happy to receive the news.

### **Self-managed energy efficiency bill proposed**

Vermont lawmakers are considering setting up a pilot program that would allow up to 20 businesses to run their own energy efficiency programs. Funds currently paid to the energy efficiency utility could instead be used by the business to make direct investments in electric and thermal efficiency and productivity measures. ## You can be a charging destination

Do your employees or customers own plug-in hybrid or electric cars? Would you like them to be able to charge at your business? VEC is offering bill credits to businesses and public entities, like municipalities and schools, [that install charging stations](#) that are available to the public. The bill credit is \$500 per connection, i.e. \$500 for a one-head charger, \$1,000 for a two-head charger.
